To receive the report from the Police and Housing Association

(Inconsideration of Sgt Price's working, the Chair brought forward these two items and consolidated with the "public participation)

a) Report from PC Harby

The presentation and report from Sgt D Price included the following highlights: -

- The police are aware of issues at both 41 & 41a Ripon Road
- There are, subject to resources, an increased police attendance in the area.
- The location rehouses offenders and has been do so for 15 years without too much trouble previously.
- There have been reported 3 incidents at either address in the past 5 months which is by comparison, low to other areas.
- He has spoken to Tesco's who have no further issues of shop lifting or incidents on their premises.
- He confirmed that each occupant had an independent case worker, and the police are trying to improve communications between themselves, the housing association, and the case workers.
- He asked that if an incident occurs, please report it to either 999 if it urgent, 111 for non-immediate incidents or Crimestoppers.
- BUT if you report something then please have details and/or evidence.
- DO NOT RESORT TO VIGILANTISM ALLOW THE POLICE TO DO THEIR WORK.

AB updated the questions that had been raised with the housing association with the following responses:

- The HA will withhold the category of the offender at either house.
- "Yes" the HA do consider the safety of the community when rehousing ex-offenders.
- The re-hab process of offenders is "case by case".
- The HA acknowledged that communications with the police will be improved.
- Eviction of an offender is a very long and complicated process and is only considered as a last resort.

AB will continue to chase Foundation Housing for more concise answers and assurance of safety in the community.

CD asked MH if access could be gained to the properties due to the conditions inside? MH was not aware of any complaints having been received to action.

CD also informed Sgt Price that there was evidence to suggest drug taking and rough sleeping behind the Sewage Treatment Works.

Sgt Price re-iterated that according to the data, Killinghall is a very safe place to live compared to other areas in Harrogate.

The chair thanked Sgt Price for attending and hoped the "problems" will settle down soon.

- b) Report from Cllr P Lacey regarding King Edwin Park (Penny Pot Lane) Cllr Lacey highlighted the following:
 - King Edwin Park is entering "Phase II" which will include another 200 houses.
 - The development will include shops, a community building, allotments, and a playground for children.
 - All of which will need to be adopted by either the brough council or some by the parish council.
 - Cllr Lacey is keen to encourage communications between the developer and council. He will provide the clerk with contact details for the developer.

MH reminded the council that agreements between developers and the borough council has changed in recent years whereby developers appoint "management companies" to look after developments once the building work is finished.

CD asked Cllr Lacey to ensure the development plan is followed and S106 funding is used within the community to improve footpaths and cycleways. Cllr Lacey confirmed there is a link to Orchid Way in Phase II. CD also reminded Cllr Lacey of the S106 funding that was agreed in 2015 promised substantial financial provision for investment.

Appendix A

A61/B6161 junction

Following the report from an adjacent resident about the surface and splashing of pedestrians when raining, I raised this with Area 6 highways, and the resident kindly provided some photos which I have sent on. This is particularly important as there are plans in this financial year to refresh the lining at this junction as part of the safety audit, and so I would think this needed to be dine prior to this. I await a response.

A61/Malt Kiln Lane junction

The collapsed Yorkshire Water gulley has been repaired. There is an outstanding job to clean the gullies which I am tracking.

Penny Pot Lane

Gullies on penny pot lane have been cleaned out at my request. The Army Foundation College are keen to see what can be done to reduce traffic speeds on this stretch, and I have requested officer support to review. I know this was rejected some years ago (before my time as NYCC councillor), but a lot has changed in that area since, not least the opening of the NYC waste recycling centre.

Killinghall Moor Community Park

I am working with Killinghall Nomads FC to see what support I can give to improve the quality of drainage on the site. I have allocated half of my 2024/25 locality budget to them (£5000). I have arranged for all the gulleys to be cleaned out (completed) but am trying to track down drainage plans for the site as this may help in scoping out next steps.

New development quality concerns

Andrew Jones MP has been focusing attention on the poor quality of finish in new developments, and in particular the Harron Homes development off the A61. I have forwarded similar concerns about Chene Hall to see if he can assist. More generally, I am trying to establish when both Chene Hall and Cautley Drive will be adopted (although of course I only want them adopting when quality issues are resolved as they should not fall to the taxpayer).

Crag Lane

I inspected Crag Lane in respect to the Yorkshire Water works, and all the temporary passing points appear to be constructed satisfactorily. The significant road defects also appeared to have been fixed.

Local Plan

A call for sites has gone out to assist in the preparation of the new county-wide local plan. The North Yorkshire Local Plan, which the council aims to adopt by 2028, will set out where development will take place across the county over the next 15 to 20 years. It will also include policies and strategies that planning applications will be considered against. Sites put forward for consideration will be subject to a lengthy process that will take several years to complete and will include independent government examination of the plan and the proposed sites. In terms of the impact on the existing legacy Harrogate Borough Council Adopted Local Plan, this remains valid, and as long as housing supply remains healthy then the area should be protected from inappropriate development. As of 1 April 2023 we can demonstrate a supply of **7.7 years**, which is relatively unchanged from the previous year (7.3).

Mayoralty

On a personal note, my term as Mayor of Harrogate comes to an end on 30th May. A new mayor will take over until May 2025, and should a town council be created for Harrogate then I would expect this to be from 2025 when they would appoint their own mayor in perpetuity, and NYC councillors would no longer serve as trustees in this respect.
