Appendix A

Planning Applications

As reported last month, the only housing application submitted to the council so far following the flurry of recent public consultations is the outline planning application for residential development for up to 55 dwellings at Picking Croft Lane. I am verifying that the decision level for this application will be the Harrogate & Knaresborough Planning Committee, and will report back any progress in due course.

Crag Lane

I have had an overwhelming response from residents of Crag Lane that they would like the temporary passing places installed as part of the capital works by Yorkshire Water retained on a permanent basis. I know the highways team have been in touch with you to advise that they are supportive of them being retained, and I will follow this up to ensure that this happens. I realise that there will also need to be some repair work on Crag Lane when the Yorkshire Water works are completed which I will follow up on.

Tesco Roadworks Diversion

My suggestion to retain the current diversion arrangements when the works on the A59 move to the Eastbound carriageway has been confirmed, with works set to continue until 23rd November. I recognise that the impact of these works has been wider that the official diversion route, but in the circumstances I think this has been as good as one could expect considering the scale of the disruption.

Church Lane Lighting

I am still waiting for a costed design, which I will share asap. I recognise that the parish council are waiting for this design before giving final approval for the scheme.

Adult Social Care Inspection Report

I am responsible for adult social care across the whole of North Yorkshire Council. An inspection by the Care Quality Commission took place earlier in the summer and the council has been rated as 'Good', with an overall score of 81 out of 100, which is currently the joint 3rd best score of any council in the country. An inspection by the Care Quality Commission provides a very clear barometer for any local authority to see how well it is doing in providing such important services. To have received such an encouraging report is testament to all the hard work, determination and talent of our staff and partners in the community, including people who use care and support services.

King Edwin Park Development – Liaison Councillor's report Page 1 of 1 NS (27 October 2025) Roads

Tarmacing roads and pavements has been completed on:

- Ingleborough Drive
- Stainmore Grove
- Whernside Close

The contractors (Til-ex) have done a lovely job; smooth tarmac, and ironworks and kerbs finished nicely. The possibility of confusion over the planned traffic calming measures on Ingleborough Drive, reported in the 6th October meeting, has been resolved. They will be installed later when there are less frequent large vehicle movements.

Neighbourhood Watch

Killinghall Parish Council has donated the leaflets, window stickers and cards requested in the last Council meeting. Only the lamp post signs remain to be bought; unfortunately, these are out of stock now.

The first online meeting of the local volunteers took place on Friday 17th October. There were four attendees including the co-ordinator, but it is early days and there are three more volunteers. The Council's donation was received well, and distribution to homes on the estate is due to begin soon. Speeding was a concern introduced during the meeting, especially now that road surfaces have been improved. The coordinator is developing a website for the estate's scheme at kepnw.org.uk.

Appendix C

Good Morning Rob

We held our first Killinghall residents meeting yesterday regarding the Bellway proposals for developing the land on the A61 approach into Killinghall. (We had to get in our cars incidentally and drive to the Curious Cow as there is no pub or free meeting facilities in the village!!!)

I just wanted to keep the Parish Council up to speed and also to request help with some info (see below).

Our intention is; when planning permission is sought; to vehemently oppose this development, acting on behalf of our community of residents to ensure that ALL stakeholders involved in any decision making; Developer, Parish, Borough, County Council and Highways are held accountable for their decisions, operate with transparency and uphold their legal obligations to the community.

This will be directly be inline with Harrogate Borough Council's own vision and criteria for development as set out in their Local Plan dated 2014-2035 and agreed in March 2020.

And with obligations under Section 106 of the Town and Country Planning Act 1990, requiring Developers to fund infrastructure projects like schools [we have a very powerful letter from the Head of Killinghall school about how the school is maxed to capacity and the knock on effect to the wellbeing of the students, parents and surrounding community], roads (see below) or healthcare facilities (our own GP surgery has recently closed its door) and measures to reduce the environmental impact, or setting limits on carbon emissions.

Our 'fight' will be on two main fronts:

1) SAFE and 2) SYMPATHETIC

to the locality; enhancing the community and mitigating any risks the development poses to our residents.

1)SAFE - what are the measures, initiatives and investment into our road infrastructure to ensure the safety of our residents and users of this treacherous stretch of the A61?

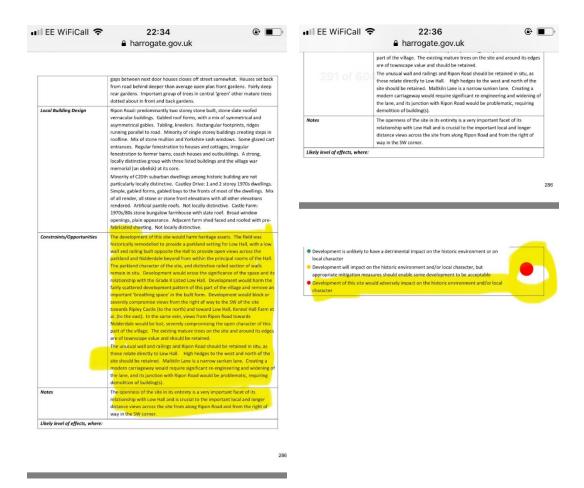
Is the PARISH COUNCIL able to make available to us the below data pertaining to this stretch of between Ripon and Harrogate, in the last 10yr period since Harrogate Council created their 'Local Plan'?:

- which administrative body maintains and makes decisions about this road? NYCC, Highways??
- Traffic surveys- volumes, types of vehicles, destinations?
- Air pollution data
- Number of incidents and fatalities
- Evidence of adjustments or improvements that have already been made to the A61 through Killinghall which have directly and positively benefited journey times, safety of residents and users and emissions

2)SYMPATHETIC - how will ALL stakeholders protect the historical integrity of our village? The land was rejected in the last round of 'Call for Sites' on its historical importance (see attached document by Harrogate Borough Council stating the reason why it was rejected).

How can this stance flippantly change a few years later to fulfil a Government housing quota rhetoric?

This piece of ancient land has imposed itself on our villagescape for over 400 years. Created by the Strother family as 'parkland', belonging to and hiving aspect to the most ancient and important buildings in Killinghall of Low Hall, Kennel Hall Farm and cottages. This is the final, recognisable piece of Killinghall to be untouched, truly the last remaining bastion of ancient 'Chenehalle',



We do empathise and understand the hardships of our farming community. However, our little village has seen UNPRECEDENTED development on its agricultural land over that last 7 years, with ZERO in return to our community. (I could add facetiously the 'adult gym equipment' at the Glebe!!).

Finally, we have identified that in order to successfully counter this development, we don't just need the data, we need critical mass. We already have already garnered much traction with our online petition. I our next phase, we will be knocking on doors in order of implementing a directory of all Killinghall residents by email, so we can quickly and effectively mobilise initiatives, circulate information and create a powerful collective voice.

I will keep you up to speed with further meetings, and look forward to your assistance with the provision of data regarding the A61.
